**Description of Incident:**

June 28, 2022, approximately 1922 hours, I was dispatched to 238 Allegheny Ave. for a report of an assault during a council meeting.

I arrived to the address a few minutes later and was greeted by Randall CLOAK. CLOAK advised that he was assaulted during the council meeting that evening by Richard DOSCH. CLOAK advised that there is some turmoil between council members and the president of council, CLOAK. CLOAK stated that he had told Richard DOSCH "Go fuck yourself." CLOAK advised that after the council meeting, DOSCH had pushed his fingers into CLOAK's chest. CLOAK advised that he spoke with his attorney and wanted assault charges pressed. I advised that it would be harassment at best. CLOAK was ok with that. I attempted to make contact with Richard DOSCH at his residence with no luck.

I'll go back next shift to follow up with DOSCH.

Before the end of the shift, Richard DOSCH called in and stated police were at his friend's residence earlier. I talked to DOSCH and he alleged the same situation happened earlier that CLOAK did. DOSCH advised that after the council meeting, there were words said between the two parties of CLOAK and DOSCH but DOSCH said that CLOAK ran into him as he was talking to other people. DOSCH said his hand did come in contact with CLOAK and CLOAK became upset. DOSCH advised that there were other people there that witnesses this and that he did not intentionally put his hand on CLOAK. One of the witnesses was Judy KENNEDY. KENNEDY advised that DOSCH did not intentionally touch CLOAK but it was incidental.

I advised that since it was between council members, I would throw it in the Chief's box and allow him to read the report before anything further happened.

Judy KENNEDY and Richard DOSCH were requesting a phone call from the chief at 724-664-7512.

July 11, 2022, approximately 1000 hours, I went over to Applewold Borough building and spoke with an Erica BOWSER who advised that she was present the night of this altercation that is in question. BOWSER said that she isn't taking anyone's specific side and that she has no relationship to either one, there was nothing conducted or done that night that should have ever been reported to the police and

that everyone in question was acting immature. BOWSER said that she was there when CLOAK ran into DOSCH's hand and that DOSCH did not intentionally strike or put his fingers into CLOAK's chest. This was advised by DOSCH previously as well.
